Recall Description

The subject vehicles have a sensor in the driver-side front door that is connected to the airbag system control unit by electrical wires. One of these wires can fracture over time. If this occurs, the airbag warning lamp could illuminate and the sensor in the door could become inoperable.

Remedy

Any authorized Toyota dealer will inspect the driver-side front door wire harness and, if necessary, replace it with an improved one FREE OF CHARGE.
